The ICSS 'rip-off' continues, due to a loophole in regulations

The regulatory regime

In response to concerns about the harm that may be caused to consumers by a certain type of ICSS service, **PhonepayPlus** has introduced a new series of regulatory requirements (including a "prior permission regime"). This was finally announced on 24 April 2014 – see this link.

This was aimed at stopping those who present consumers conducting internet searches for government bodies and companies with a more expensive indirect contact number than the direct number which they had hoped to find. In particular it requires announcement of the nature of the 'service' and declaration of the cost of the call, through an 'alert', before onward connection.

In many respects, it could be said that this was very effective, because the majority of the services required to comply with the regulation chose not to continue under these terms

... HOWEVER ...

they simply moved their operations away from the current scope of the **PhonepayPlus** powers, by switching from 087 to 084 numbers.

PhonepayPlus defines ICSS (Information, Connection and Signposting Services) as follows:

"Premium rate services, excluding full national directory enquiry services, that provide connection to specific organisations, businesses and/or services located or provided in the UK; and/or which provide information, advice, and/or assistance relating to such specific organisations, businesses and/or services."

Clearly any call re-direction service, applying a premium charge, would fall within the terms of this definition, as generally understood. There is however a problem, due to the terms of the "PRS">the "PRS" condition" as set by **Ofcom** under the terms of the Communications Act 2003 – section 120.

Many categories of service, e.g. chatlines, internet diallers and "sexual entertainment services", are classified as being "Controlled Premium Rate Services", regardless of the level of the Service Charge which applies. ICSS are not however regarded as such a category.

At present, the only way that ICSS may fall within the scope of the **PhonepayPlus** regulations is by being provided through a type of number (e.g. 087 / 09) which would cause any service to be classed as CPRS, due to the level of the Service Charge (i.e. greater than 7p per minute/call).

This is clearly unacceptable. We make a strong representation to **Ofcom** through our response to the current consultation on Approval of the **PhonepayPlus** Code of Practice (fourteenth edition).

Our recommendation

The terms of the regulatory regime referred to above would be extended to cover ICSS services provided on 084 numbers with the addition of the following line to subsection (e) of section 2 of the "PRS condition" as found on this page:

(vii) the service is an Information, Connection and / or Signposting Service

Such a change must be made to eliminate the "consumer harm" identified by **PhonepayPlus** in justifying its imposition of the regulatory requirements. In some cases, the level of Service Charge alone indicates the nature of the service, justifying classification as a Premium Rate Service. An ICSS is a Premium Rate Service at whatever level of revenue is necessary for it to be sustained.
